Entry Requirements - Proof of Citizenship

The following are the only ACCEPTABLE forms of Proof of Citizenship:
No other forms will be accepted and NO REFUNDS can be given to travelers who are denied entry.

1. A valid passport (not expired)

-OR-

2. State issued (not hospital issued) copy of a birth certificate and a government issued photo I.D. (both are required)

-OR-

3. Certified Naturalization Certificate and a Government issued photo I.D. (both are required)

Married or Divorced Women

A married or Divorced woman traveling in any name other than what is on their documentation must supply a Marriage license or Divorce Decree (A photo copy is acceptable.)

Children under 18

Children under 18 must have the NOTARIZED written consent of both parents and a birth certificate. Minors traveling with only one parent need a NOTARIZED letter of consent from the other parent or legal documentation giving that parent sole custody or a death certificate if the other parent is deceased.

Travel Insurance

We strongly recommend that you protect your vacation investment with low-cost travel insurance. Travel health and accident, baggage and trip cancellation insurance is available. Unexpected circumstances can occur at anytime, anywhere and anyone. A sudden emergency just before or even during your vacation may force you to cancel or interrupt your trip. Making Your Reservation

Once you have received a price quote, please phone or e-mail the office with the correct legal names of your travelers. We will make your booking and guarantee the price we quoted at that time. A deposit of \$200 per person is due at that time. We will use the tour operator with the best rate. Promotional or sale fares may require a higher deposit. Bookings can be made up to 3 days before travel. Upon receipt of deposit, your tentative booking becomes a confirmed reservation. Payment in

full is due 45 days prior to departure. Booking made less than 45 days before departure require immediate payment in full. Be sure to make your payment on time as we cannot hold reservations beyond the payment deadlines

Payments

Documentation

Documents including tickets and vouchers are shipped 2-3 prior to travel, and after receipt of payment in full. A separate \$10 charge will be made to your credit card to cover delivery of documents. Overnight delivery is \$15.00. International Fedex is will be charged the same amount as the Fedex charge. Always check your documents for accuracy immediately upon receipt.

Late Bookings

Bookings made 14 days or less before departure will incur a \$25 fee to cover additional expense reservation and expedite documents.

Revisions/ Changes

Once payment has been received, a fee of \$15 will be charged by AJV each time changes are made to a reservation to cover administrative costs. Again, change penalties vary by tour operator.

Cancellations

To minimize penalties, please advise us immediately should you wish to cancel a confirmed reservation. Cancellation charges are as follows:

46 days or more/\$50.00pp
45-22 days/ \$150 pp
21-00 days/ \$200 pp

Additional charges: Depending on the tariff, from \$50.00 to the full amount of the fare may be forfeited. Hotel penalties often apply, and the amount varies by hotel.

Cancellation penalties may vary depending on travel dates and hotel, due to certain hotel cancellation policies and airfare tariffs. Penalties up to the full amount paid may apply over holidays, peak periods and promotional sales. Cancellation insurance is highly recommended.

Refunds

No refunds can be made for unused services or inclusive. All tickets and vouchers must be returned before a refund can be issued. Please allow 4-6 weeks for processing refunds after notifying us to cancel reservation.

Families Traveling with Children

Special children fares are available for children (ages 2-11) and junior ages (12 & older). Children stay free and/or receive special discounts when traveling with parents to participating hotels. Please ask for details. Infants under 2 years of age fly free (departure taxes additional), provided the child does not occupy a seat and sits in parent's lap. Additional bedding such as rollaways and cribs are not included and if available, are payable directly to the hotel.

Baggage

Air Jamaica allows each passenger to travel with 2 checked bags (maximum weight 70lbs each) plus one carry-on bag (maximum weight 50lbs). Additional bags may incur excess baggage charges.

Not Included in the Package Price

Porterage at airports, tips to sightseeing guides, and unless otherwise indicated, tips in restaurants, to hotel bellmen in chambermaids; items of a personal nature such as laundry, phone calls or any items not specified as included.

Island Departure Tax

Not included are per person departure taxes paid at the airport when exiting. The following departure taxes payable at local currency were applicable at time of printing and equivalent to:

Jamaica-\$27 US - May be included please ask your agent.

Barbados - \$15 US

St. Lucia - \$21 US

To verify if Jamaican departure tax is included in your airline ticket check the "fare ladder" in the bottom left hand corner of the ticket. If there is a tax coded "wd" this indicates that the tax has been paid.
